



CFP Smart Package

(Effective from 1 January 2010 to 31 December 2010)

Option 1:- Single Payment

This package is open to all new learning members who choose to settle CFP program fee in advance and in one single payment, they will enjoy substantial savings up to 27% discount on normal fee:

Option 2:- Installment Plan - 4 x Monthly Installments

Those enrolled under CFP Smart Package can opt for 4 x monthly installment plan as follows:-

Installment	Amount	Remarks
1 st Installment	RM1,200	* For those who sign up on 1 st half of the month (e.g. May 1 – 15), the next installment due date will be on the 15 th day of the following month (e.g. June 15)
2 nd Installment	RM1,600	
3 rd Installment	RM1,600	* For those who sign up on 2 nd half of the month (e.g. May 16 - 31), the next installment due date will fall on the 30 th day of the coming month (e.g. June 30)
4 th Installment	RM1,200	
TOTAL	RM5,600	* Application Fee RM100 must be settled upon registration.

Terms and Conditions:

1. Learning members enrolled under the KMDC CFP Smart Package must complete their CFP program within three calendar years from the date of enrollment.
2. The KMDC CFP Smart Package is not transferable and applicants are not entitled any other offers.
3. Free Gift: Free 6-month subscription of Smart Investor magazine for those who settled the program fee up front in one single payment (Option 1 only).
4. **Payment of Fees:** Fees may be paid in cash or by cheque, bank draft, or credit card (payable to **KDU Management Development Centre Sdn Bhd**).
5. **Late Payment Penalty:** All fees must be paid in full on due date, and in the case of those who opt for single payment, the commencement date of the course. There is a grace period of 7 days from the due date for fees to be settled. A **late payment penalty charge of 5%** will be imposed on ALL outstanding fees after the grace period.
6. **Refund of Fees:**
 - a. All fees which have been paid are **NOT** refundable unless: the course does not commence at KMDC, or candidate has given **VALID** reason(s) and is accepted by the management.
 - b. All withdrawals are subject to an administrative charge of RM200 per module. Candidates are advised to contact staff from the KMDC Programmes Department **in writing** as soon as the situation for withdrawal arises, stating reason for withdrawal.
